4. In 2 years before the date of application and during the period of membership, the company/business must not be found liable for copyright infringement
5. The company/business must pay a fee to **RIKE ASSOCIATION LTD. (Please see the membership benefits form to select your preferred membership tier)**. In addition to membership payment, the company/business will be required to pay a premium annual fee of KES 3,000 which provides an all-access pass to RIKE benefits and thereafter, an annual fee of KES 1,200 (KES 100 for every month of the year).
